About the Role

Purpose of the role

The North Island Environmental Lead is responsible for providing oversight of KiwiRail's Environmental Risk and Compliance obligations by working with the KiwiRail Business Units and Support Functions in the North Island. This involves understanding above rail and below rail functions, processes and procedures and working closely with the Business Units to identify environmental risk and apply appropriate controls across all phases of their business, sites and projects to comply with relevant legislation and implement best practice to avoid or minimise environmental impacts.

The North Island Lead will assist the General Manager in socialising and delivering the Environmental Risk Strategy, and implementing the SHE and Environmental Policies, Principles, Standards and Guidance tools. This includes providing feedback on fit for purpose systems and assisting with developing improved systems and tools. The role is also required to work with the Environmental and Safety, Health and Wellbeing Assurance Team to ensure the environmental tools and information in Sharepoint are relevant and easy for the business to access.

The North Island Lead is responsible for working with the Business to implement the Environmental Management System across the North Island. The North Island Environmental Lead will also be responsible for providing knowledge leadership on environmental risk assessment and controls, and co-ordinating the Environmental Team's response to consent non-compliance and environmental incidents. As part of the monitoring and compliance function of the role, the North Island Environmental Lead will co-ordinate with the Environmental Advisors, and other Business Units, to complete site inspections, and environmental compliance audits within their geographical area. They will work closely with the Environmental Compliance Manager to ensure compliance activities are undertaken to a consistent and high standard, and outputs are appropriately and completely recorded in the KiwiRail incident and compliance management systems. The North Island Lead will also work closely with the Environmental Compliance Manager to ensure the Consent Compliance Database is kept up to date, reporting is accurate, and non-compliance actions are being managed.

The role will assist in raising environmental awareness across the North Island. This will involve developing and delivering training, working with the Learning and Development team to organise training across the business, attending briefings and toolboxes to communicate innovations, best practice, environmental standards, guidance and lessons learnt.

The role will have a strong interface with the Safety, Health, and Wellbeing (SHW), Property, RMA Planning, Legal, and Sustainability Teams and will help facilitate the involvement of these teams across planning, operations, renewals and maintenance undertaken by the wider business.

The North Island Lead is responsible for managing key relationships associated with environmental compliance and management within the North Island. E.g. Council Compliance, DOC, Heritage NZ.

The North Island Environmental Lead is responsible for the management of the Environmental Advisors located within the North Island. They will have day to day responsibility for work allocation for the Environmental Advisors, as well as providing supervision of the Advisors work progress, and quality. The career development of the North Island Environmental Advisors is a key aspect of this role.

Key Accountabilities

Within the area of responsibility, this role is required to:

- Establish and maintain productive working relationships with internal stakeholders e.g. Business Units, Support Functions and Project Teams carrying out work where a potential environmental risk exists, and providing advice and solutions to Business Units and project teams on environmental matters.
- Work with the General Manager Environment to develop and ensure the continuous improvement of KiwiRail's environmental management strategies, policies, objectives, principles, standards and guidance tools plans, etc and integrate these into the existing SHE Management system.
- Assist the General Manager Environment in developing the KiwiRail Environmental Management System which sits under the umbrella of the SHE Management System.



- Recognise and escalate key risks and legal implications to the General Manager Environment in a timely manner
- Oversee responses to significant environmental incidents, ensuring thorough investigation and appropriate engagement with regulatory authorities, mana whenua, and other external stakeholders.
- Work with the Environmental Compliance Manager to co-ordinate a consistent approach to the Environment Team's response to and reporting of consent non-compliance and environmental incidents.
- Work with the Compliance Manager to facilitate the management of potential or actual environmental related enforcement to ensure applicable people within the business have been notified, an action plan is developed and communicated, timely reporting to regulators has occurred and actions are implemented within agreed timeframes.
- Work with the Environmental Compliance Manager and the Environmental Advisors to ensure that incident reporting is accurate and up to date, and that reporting data bases such as ORA and the Consent Compliance data base are kept up to date and are accurate.
- Establish and maintain key relationships with North Island Council staff, particularly those with an enforcement or review/compliance function.
- Establish and maintain key relationships with other key stakeholders who KiwiRail may interface with when conducting our work e.g. Department of Conservation, Heritage New Zealand, iwi/hapu groups, etc.
- During performance of the role, identify areas of the business where environmental awareness requires improvement.
- Work with the General Manager Environment and wider team to facilitate or develop, implement and deliver environmental awareness or practice improvement training across KiwiRail.
- Work with the Business Units and Environmental Advisors to development and/or review environmental management plans which include applicable risk assessments and controls.
- Develop and implement an audit schedule for the North Island based on project and activity risk and schedule the Environmental Advisors to complete required audits.
- As required, assist the Environmental Compliance Manager to produce up to date and accurate environmental compliance status and risk reports for the General Manager Environment, Business Units and Senior Management.
- Advise the business on day-to-day environmental queries.
- Provide leadership by attending toolboxes and assisting with delivering important messages and/or lessons learnt to the business.
- Assist the Environment General Manager in communicating environmental best practice, new or updated Environmental Systems, lessons learnt or other helpful tools to the business. E.g. Express Articles, SHE Alerts, toolbox notices.
- Manage the Environmental Advisors in the North Island which includes their work allocation, ensuring proactive risk management, reviewing site and project management plans in a timely manner, incident management, assurance, tracking and assisting with their career development and fostering an inclusive and productive team culture.
- Work with the wider business to assess whether applicable environmental resource is available to manage risk on respective projects, sites and activities. This may include taking a hands-on approach.
 E.g. Interislander and Ferry Upgrades
- Keep up to date with industry best practice environmental management practices and legal obligations
- Collaborate with KiwiRail Teams, consultants, contractors, and stakeholders to deliver projects on time, on budget, and in compliance with environmental obligations.

Key challenges

- Ensuring the consistent application of KiwiRail's Environmental Management System and compliance practices across multiple projects and geographies.
- Implementing a collaborative approach with internal stakeholders to consistently deliver projects and/or undertake day to day operations in an environmentally compliant manner. E.g. Project/Site Team, Property RMA and Env Team



- Building strong, effective partnerships with mana whenua and local regulators to support cultural and environmental goals within a construction framework.
- Balancing operational demands with the need for strict environmental oversight and sustainable practices.

Decision Making

The position is accountable for decisions regarding environmental compliance and risk management across either the North Island (NI) or North Island (SI).

Key decision-making requirements of the position include:

- **Determining Compliance Strategies and Priorities:** Assess project and operational requirements and determine the most effective strategies to meet environmental compliance obligations. This includes prioritising actions and resources to address areas of highest environmental risk and ensuring that projects, sites and operations adhere to both KiwiRail's environmental standards and New Zealand regulatory requirements.
- **Responding to Environmental Incidents:** Collaboratively decide with the Business Unit on the immediate actions and long-term corrective measures following environmental incidents. This includes evaluating the severity of incidents, coordinating with relevant authorities, and implementing necessary mitigation or remediation measures to minimise impact and prevent recurrence.
- Managing Stakeholder Engagement and Communication: Make key decisions on how to engage and communicate with external stakeholders, including regulatory authorities, mana whenua, and local communities. This involves balancing project objectives with environmental and cultural considerations, ensuring that stakeholder concerns are addressed, and maintaining KiwiRail's reputation as a responsible corporate citizen.
