About the Role

Purpose of the role

As the Metro Protection Operations Manager - Auckland your primary responsibility is building and maintaining KiwiRail's Protection brand internally and externally. The Metro Protection Operations Manager - Auckland will provide the day-to-day leadership of the people and functions associated with the Auckland Metro Protection business unit. This role focuses on managing protection measures within high-density, urban rail environments, where safety risks and operational demands are heightened due to complex rail traffic and diverse stakeholder needs.

The Metro Protection Operations Manager - Auckland leads metro-specific protection strategies, coordinates compliance efforts, and collaborates closely with stakeholders to ensure the continuous safe operation of KiwiRail's metro services. The Metro Protection Operations Manager - Auckland will help lead and coordinate the most efficient and productive track protection method to maximise field team productivity and minimise the disruption to trains without compromising safety.

Health and Safety is an important part of how KiwiRail operates. You will be a safety leader and will be expected to "walk the safety talk"

Key Accountabilities

Within the area of responsibility, this role is required to:

- Lead and manage Metro-protection services to ensure the safety of internal and external customers operation in the rail corridor.
- Build and maintain strong relationships with both internal and external customers, ensuring effective collaboration to support a seamless protection service.
- Deliver safety activities safety that align with national safety policies and address local risks and requirements.
- Apply subject matter expertise and support to programmes focused on continuous improvement of policy and procedure linked to compliance and safety.
- Design and lead improvement initiatives with the workforce (within the context of High Performance, High Engagement protocol as necessary) and create a highly engaged, empowered team.
- Conduct regular assessments and audits of protection activities to monitor compliance, safety performance, and efficiency.
- Lead post incident learning and timely closure of corrective actions.
- Develop, test and deliver innovative approaches to the task of protection, aligned to the future needs of the metro areas.
- Collaborate with other Protection Managers to share knowledge and lessons learned.
- Collaborate with other leaders to align with Auckland Metro Operations.
- Provide leadership and development to Protection Team Leaders and Protection staff, fostering a culture of safety, high engagement and continuous improvement.
- Support the Protection Manager Metros when required and as requested.



Key challenges

- Balancing metro safety requirements with operational demands and service delivery to ensure minimal disruption to rail services.
- Navigating and managing relationships with various stakeholders across regions, metros, and central
 operations to ensure cohesive safety management.
- Support and guide the transformation of the Protection Team Leaders to fully engaged and effective leaders.
- Lifting safety performance to reduce incidents and lift safety standards to achieve and consistently meet KiwiRail safety targets.
- Stakeholder management is critically important in a large and complex organisation, including the RMTU union.
- Adapting safety protocols and protection planning to address changing rail network conditions, weather impacts, and other environmental factors.
- Mentor, coach and guide Protection Team Leaders and Safety Protectors to operate efficiently and safely while embodying safety leadership.
- Support the continuous improvement of the wider Auckland Metro Protection work group across Safety, Health and Wellbeing.
