About the Role

Purpose

The purpose of the Marine & Safety Superintendent role is to assist in the assurance and compliance verification of the ship's operations with flag, class and KiwiRail requirements. The role shall through the application of SHE assurance, verification and investigatory techniques support the continued development and improvement of the SMS, assets and the organisations safety culture. Assist implement a robust audit programme and ensure effective action is taken for audit and incident outcomes. The role will lead the implementation and development of the organisations bridge resource management (BRM) practices.

Key Accountabilities

Within the area of responsibility, this role is required to:

- Manage the internal and external ship audit/inspection program
- Ensure the fleet holds valid trading and survey certificates at all times.
- Monitor and progress the close out of all non-conformities, observations, recommendations, corrective or
 preventive actions in a timely manner and liaise with the ships to ensure that actions are followed through.
- · Conduct Navigational incident investigations
- Conducting navigational/ BRM assessments and being a BRM Champion

Liaise with Maritime NZ and Class on regulatory and technical issues. Monitor and ensure the emergency response capability of the ships and organization is maintained to high standards. Maintain a professional relationship with regulatory authorities Assist in the production of fleet and ship specific policy, procedures, manuals and other instructions as required Assist with the creation of fleet memos, safety bulletins and procedures as required Where required, attend and ensure dockings and surveys are undertaken in accordance with manufacturer and regulatory standards |





- Carry out ship safety inspections in line with SMS guidelines as required.
- Ensure the standards for shipboard maintenance, including LSA, FFE are maintained through audits and inspections.
- · Creating /Developing audit checklists and reports for all audits.
- Assist with the recording and monitoring the results of all internal and external audits and inspections and preparing reports for management review meetings as required.
- Conduct annual navigational safety and BRM audits to ensure vessel and bridge team compliance with the companies BRM / BTM requirements and those standards are consistent across the fleet.
- Liaise with MNZ as required for the completion of flag state inspections including travel, reporting and close out of any findings within the timeframes given.
- Provide direct feedback to the ship on the outcome of the navigational audits at the conclusion of process. Identify any recommendations or corrective actions.

Provide direct feedback to the Fleet Operations team and master's on the outcome of audits/safety inspections at the conclusion of process and issue any non-conformities and/or observations and in conjunction with the Masters agree on all corrective and preventative actions.

- Following the safety inspection prepare the necessary report outlining any non-conformities and/or observations and the required corrective actions.
- Monitor and progress the close out of all non-conformities, observations, recommendations, corrective or preventive actions in a timely manner and liaise with the ships to ensure that actions are followed through.
- Assist to ensure that all corrective and preventative actions are effective and verified as being carried out.
- Ensure that all preventative measures identified in audits/inspections are where necessary incorporated within the SMS to avoid a recurrence.
- Compile and agree the audit programme for each year including ensure any expenses are budgeted

Assist with any investigations as may be required

- Onsite co-ordination post incident and evidence collection as needed
- Conduct interviews as required
- Write investigation reports where requested
- Review drafts and provide constructive feedback on investigation reports
- · Liaise with MNZ /TAIC /WorkSafe on incidents as required
